Regulation (EC) No.1907/2006 of the European Parliament and of the Council of 18th December 2006

Dear Sirs,

With regard to this regulation covering the Registration, Evaluation, Authorisation and Restriction of Chemicals in the European market, which entered the effective phase of its introduction on 1st June 2008, we are pleased to advise as follows:

- 1. CEMBRE is a downstream user of such substances and, as such, is not responsible for their pre-registration or registration. Such substances, used in our manufacturing processes, will have already been pre-registered or registered by their suppliers.
 - Suppliers have been contacted and have confirmed they will fully meet all obligations under the Regulation within the specified timescale.
 - In any case, to guarantee our customers uninterrupted and correct supply of our products, CEMBRE will actively monitor suppliers and will use only pre-registered or registered substances during this period. CEMBRE neither manufactures nor directly imports such substances, nevertheless it is clearly aware of the significant impact that the REACH Regulation will have on the entire manufacturing chain. For this reason CEMBRE will engage with its suppliers to specify identified uses of such substances within its products, for the purpose of Safety Data Sheet (SDS) compilation.
- With regard to Substances of Very High Concern (SVHC), CEMBRE products do not contain any substance problematic to human health, that is present in the Candidate list, updated to 16.12.2013, Annexe XIV of the REACH Regulation.
 - In accordance with section 33 of the Regulation, CEMBRE will inform its customers about substances which may be added to this Annexe. In addition, within 45 days of receipt of an appropriate request by a customer, CEMBRE will provide information regarding such substances that are present in a concentration higher than 0,1% (weight / weight) in products supplied to that customer.
